Police

- 1. Offences reported to the police, exclusive of contraventions, decreased by 4.9% from 47,792 to 45,457 in 2018, mainly due to drop in theft (-16.9%).
- 2. Road traffic contraventions increased by 1.4%, from 240,101 in 2017 to 243,425 in 2018, mainly due to "motor vehicle licence not affixed" which increased from 10,588 to 12,376 (+16.9%) and "failing to produce driving licence on demand" (+14.4%).
- 3. Some 19,156 persons were suspected, arrested and/or cautioned in the course of criminal investigations in 2018, down by 26.1% from 25,936 in 2017. The number of persons prosecuted decreased by 23.7% from 15,491 in 2017 to 11,823 in 2018.

Office of Director of Public Prosecutions (ODPP)

4. From 2017 to 2018, the number of cases referred by the Office of Director of Public Prosecutions to the Intermediate and Supreme Courts decreased by 7.1% from 1,444 to 1,342.

Judiciary

5. The number of criminal cases lodged increased by 1.3% from 99,885 in 2017 to 101,208 in 2018. During the same period, the number of criminal cases disposed of dropped by 3.9% from 103,387 to 99.334

Prison

- 6. Out of the 3,627 adult convicts admitted to prison in 2018, some 70.2% were re-offenders who had been imprisoned in the past, regardless of any observation period
- 7. An average amount of Rs 800 was spent daily to maintain a detainee in 2018 in the Island of Mauritius.

Probation

- 8. In 2018, some 254 probation orders were issued, representing a rise of 19.8% compared to 212 in 2017.
- 9. The number of offenders, subjected to community service orders, decreased by 0.8% from 611 in 2017 to 606 in 2018
