External Merchandise Trade Statistics

4th Quarter and Year 2022

1. Introduction

This issue of Economic and Social Indicators presents external merchandise trade statistics for the years 2021 and 2022. These statistics are compiled from declarations lodged at the Customs Department of the Mauritius Revenue Authority (MRA), by importers and exporters. Some of these declarations are usually revised at a later period and corrections are made accordingly on the computerised database at the Customs Department.

Thus, while revised figures for 2021 are published in this indicator, those for 2022 are still provisional and subject to revision as and when the Customs Department of the MRA submits latest amendments to Statistics Mauritius.

Data on external merchandise trade are compiled as per the recommendations of the United Nations General Trade System. According to this system, all goods entering and leaving the national frontier, including trading activities of the Freeport zone should be accounted for.


2. Total value of trade and trade balance

Total external merchandise trade for the fourth quarter of 2022 was valued at Rs 104,636 million, i.e. 0.7% higher than the value of Rs 103,932 million of the previous quarter and 15.4% higher than the value of Rs 90,674 million of the corresponding quarter of 2021.

For the fourth quarter of 2022, total exports (including ship's stores & bunkers) were valued at Rs 26,981 million against imports of Rs 77,655 million. This resulted in a trade deficit of Rs 50,674 million, 1.0% higher than the deficit of Rs 50,160 million of the previous quarter and 13.4% higher than the deficit of Rs 44,672 million of the corresponding quarter of 2021.

Total export proceeds for the year 2022 stood at Rs 101,680 million, representing an increase of 24.0% over the 2021 figure of Rs 81,992 million. Total imports for the year 2022 amounted to Rs 292,429 million, representing an increase of 36.1%, compared to Rs 214,836 million in 2021. The trade deficit for year 2022 worked out to Rs 190,749 million, around 43.6% higher than the deficit of Rs 132,844 million for the year 2021.

3. Exports

3.1 Total exports (Tables 1 and 3) - 4th Quarter 2022

Total exports for the fourth quarter of 2022, including domestic exports¹, re-exports² and ship's stores and bunkers, amounted to Rs 26,981 million, showing an increase of 0.4% compared to the previous quarter. This is explained by increases in the exports of "Machinery and transport equipment" (+46.3%), "Chemicals and related products, n.e.s" (+40.1%) and "Food and live animals" (+10.4%), partly offset by decreases in the exports of "Manufactured goods classified chiefly by material" (-14.4%), "Ship's stores and bunkers" (-9.2%) and "Miscellaneous manufactured articles" (-5.0%).

Compared to the corresponding quarter of 2021, total exports for the fourth quarter of 2022 increased by 17.3%. This is mainly explained by increases in exports of "Chemicals and related products, n.e.s" (+63.7%), "Food and live animals" (+30.0%), "Machinery and transport equipment" (+22.3%), "Ship's stores and bunkers" (+19.6%) and "Miscellaneous manufactured articles" (+7.3%), partly offset by a decrease in the exports of "Manufactured goods classified chiefly by material" (-4.9%).

3.2 Domestic Exports

Domestic exports for the fourth quarter of 2022 amounting to Rs 16,592 million accounted for 61.5% of total exports. Compared to a value of Rs 16,472 million recorded in the third quarter of 2022, domestic exports increased by 0.7%. When compared to the corresponding quarter of 2021, an increase of 16.6% was observed (*Table 4*).

3.3 Re-exports

In the fourth quarter of 2022, re-exports stood at Rs 6,145 million i.e. higher by 7.0% compared to previous quarter, and by 17.6% compared to the corresponding quarter of 2021. (*Table 5*)

3.4 Exports by SITC sections (Tables 1 and 3) - Year 2022

Total export proceeds for the year 2022 stood at Rs 101,680 million, representing an increase of 24.0% over the 2021 figure of Rs 81,992 million. Around 28.4% of total exports consisted of "Food and live animals" (Rs 28,903 million), 28.2% of "Miscellaneous manufactured articles" (Rs 28,657 million), 18.3% of "Ship's stores and bunkers" (Rs 18,588 million) and 12.8% of "Manufactured goods classified chiefly by material" (Rs 13,010 million).

Compared to the year of 2021, the main changes by section were as follows:

- "Food and live animals" increased by 22.6%, mainly due to an increase in exports of "Cane sugar" (+23.6%) and "Fish & fish preparations" (+22.2%).
- "Manufactured goods classified chiefly by material" increased by 18.6% mainly as a result of increases in the exports of "Pearls, precious & semi-precious stones" (+48.4%) and "Textile yarns, fabrics, made-up articles" (+5.7%).

¹ Domestic exports are defined as goods of national origin.

² Re-exports are goods which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged.

- “Miscellaneous manufactured articles” registered an increase of 12.7%, mainly explained by an increase in exports of “Articles of apparel & clothing accessories” (+9.2%).


3.5 Exports of Export Oriented Enterprises (EOE)

For the year 2022, exports of EOE amounted to Rs 50,000 million, compared to Rs 42,657 million in 2021, representing an increase of 17.2%.

Further details on these transactions will be presented in the issue of the Economic and Social Indicator on Export Oriented Enterprises, to be released on 30 March 2023.

3.6 Exports by country of destination (Table 7) –Year 2022

Analysis of exports figures by country of destination for the year 2022 shows that the European countries were our main buyers, purchasing around 40.9% of our exports excluding Ship’s stores and Bunkers, for a value of Rs 33,966 million. Among countries, the major destinations for our exports were South Africa (13.4%), Madagascar (9.0%), France (8.7%), United Kingdom (8.6%) and U.S.A. (8.0%).



Compared to the year 2021, exports to Spain, Madagascar, France, South Africa, U.S.A., United Kingdom and Netherlands increased by 51.1%, 38.8%, 21.7%, 14.7%, 13.6%, 12.1% and 11.7% respectively. On the other hand, exports to Reunion decreased by 0.1%.

4. Total Imports (Table 10) - 4th Quarter 2022

Total imports for the fourth quarter of 2022 amounted to Rs 77,655 million, showing an increase of 0.8%, compared to the previous quarter. This is due to increases in imports of “Machinery & transport equipment” (+12.7%), “Miscellaneous manufactured articles” (+8.9%), “Mineral fuels, lubricants, & related products” (+5.2%) and “Food and live animals” (+2.0%), partly offset by decreases in the imports of “Manufactured goods classified chiefly by material” (-17.1%) and “Chemicals and related products, n.e.s” (-9.5%).

Compared to the corresponding quarter of 2021, total imports for the fourth quarter of 2022 increased by 14.8%. This rise is due to increases in imports of “Food and live animals” (+30.6%), “Mineral fuels, lubricants, & related products” (+30.0%), “Machinery & transport equipment” (+23.8%) and “Miscellaneous manufactured articles” (+10.5%), partly offset by decreases in the imports of “Chemicals and related products” (-17.6%) and “Manufactured goods classified chiefly by material” (-5.6%).

4.1 Imports by SITC section (Table 10) – Year 2022

Total imports for 2022 amounted to Rs 292, 429 million, representing an increase of 36.1% compared to Rs 214, 836 million in 2021. Around 22.9% of imports in the year 2022 consisted of “Mineral fuels, lubricants, & related products” (Rs 66,831 million), 19.3% of “Machinery & transport equipment” (Rs 56,549 million), 18.1% of “Food and live animals” (Rs 52,805 million), 15.9% of “Manufactured goods classified chiefly by material” (Rs 46,480 million), 9.1% of “Miscellaneous manufactured articles” (Rs 26,554 million) and 8.5% of “Chemicals and related products, n.e.s.” (Rs 24,824 million).

Compared to the year 2021, main changes by section were as follows:


- “Mineral fuels, lubricants, & related products” increased by 80.4%, mainly due to increases in imports of “Refined petroleum products” (+83.8%) and “Gas, natural and manufactured” (+46.5%).
- “Machinery & transport equipment” increased by 34.3%, mainly due to increases in imports of “Telecommunications & sound recording & reproducing apparatus & equipment” (+48.3%), “Road vehicles” (+39.5%), “Electrical machinery, apparatus & appliances, n.e.s., & electrical parts of household type” (+31.5%) and “General industrial machinery & equipment, n.e.s., & machine parts, n.e.s.” (+20.8%).
- “Food and live animals” increased by 32.9%, due to increases in imports of “Dairy products and bird’s eggs” (+40.8%), “Meat and meat preparations” (+34.8%), “Vegetables and fruits” (+34.3%) and “Fish and fish preparations” (+29.2%).
- “Manufactured goods classified chiefly by material” increased by 23.3%, mainly due to increases in imports of “Pearls, precious & semi-precious stones” (+45.0%), “Paper, paperboard & articles thereof” (+40.6%), “Manufactures of metal, n.e.s.” (+25.2%), “Other textile fabrics” (+16.2%), “Textile yarn” (+11.0%) and “Iron and steel” (+9.5%).
- “Miscellaneous manufactured articles” increased by 25.3%, mainly due to increases in imports of “Footwear” (+49.6%), “Articles n.e.s. of plastic” (+26.2%), “Articles of apparel and clothing” (+23.6%) and “Professional, scientific & controlling instruments & apparatus, n.e.s.” (+12.4%).
- “Chemicals and related products, n.e.s.” increased by 0.3%, mainly due to increases in imports of “Plastics in primary forms” (+21.4%).

4.2 Imports by country of origin – Year 2022

For the year 2022, our imports originated from five main countries, namely: China (16.1%), India (9.8%), South Africa (9.1%), United Arab Emirates (9.0%) and France (5.6%). Among continents, Asia was our main supplier with a share of Rs 164,102 million, representing 56.1% of total imports. (*Table 13*)

Compared to 2021, total imports from South Africa, United Arab Emirates, China and France went up by 54.2%, 38.5%, 23.6% and 14.7% respectively, while imports from India fell by 14.9%.

5. Trade with Member States of Regional Organizations – Year 2022

Total exports to African, Caribbean and Pacific (ACP) States stood at Rs 24,666 million against imports of Rs 36,567 million. The trade deficit with ACP countries worked out to Rs 11,901 million. South Africa is the main supplier and buyer, with a share of 72.4% and 45.0% respectively. (*Table 14*)

Exports to COMESA member states attained Rs 11,963 million while imports from these countries amounted to around Rs 10,293 million, resulting in a trade surplus of Rs 1,670 million. Madagascar (62.6%) was the main buyer, followed by Kenya (21.3%). Our main suppliers were Seychelles (29.8%), Kenya (21.8%), Egypt (21.1%) and Madagascar (17.4%). (*Table 15*)

Trade with SADC countries showed a deficit of Rs 12,162 million, resulting from imports of Rs 33,242 million against exports worth Rs 21,080 million. The main buyers were South Africa (52.7%) and Madagascar (35.5%) and the main suppliers were South Africa (79.6%) and Seychelles (9.2%). (*Table 16*)

6. Trade in Freeport Zone – Year 2022

For the year 2022, total imports of the Freeport Zone stood at Rs 13,065 million, lower by 3.0% compared to 2021 – (*Table 12*).

The main imports of the Freeport zone were “Miscellaneous manufactured articles” “Chemicals and related products, n.e.s.” and “Food and live animals” with a share of 29.4%, 18.9% and 18.0% respectively.

Freeport re-exports were valued at Rs 13,122 million, representing an increase of 20.8% compared to 2021 – (*Table 6*). “Miscellaneous manufactured articles” and “Food and live animals” with a share of 31.4% and 25.2% respectively, were the main exports.

7. Forecast 2023

Based on trends and information from various sources, the forecast of total exports for year 2023 will be around Rs 110 billion, 7.8% higher than the total exports of around Rs 102 billion in 2022. Total imports for 2023 including one-off items such as machinery for metro terminals, will be around Rs 320 billion, 9.6% higher than the total imports of around Rs 292 billion in 2022.

The trade deficit for 2023 is forecasted to be around Rs 210 billion, 9.9% higher as compared to around Rs 191 billion in 2022.

Notes

(1) Scope and coverage

External merchandise trade statistics are compiled according to the General Trade System as recommended by the United Nations. Using the national boundary as the statistical frontier, the General Trade System is a record of all goods entering (imports) and leaving the country (exports).

Imports include goods brought in directly for domestic consumption plus goods imported into customs bonded warehouses.

Exports cover:

- Domestic exports defined as goods of national origin, that is goods produced in the exporting country.
- Re-exports which are exported in the same condition as imported or after undergoing minor operations which leave them essentially unchanged and include re-exports from customs bonded warehouses.
- Ship's Stores and Bunkers (SSB) are included in total exports and are shown separately.

Trade by parcel post is also included in imports and exports.

(2) Valuation

Imports are valued on a C.I.F. (Cost, Insurance and Freight) basis, whilst exports on a F.O.B. (Free on Board) basis.

Cost, Insurance and Freight (C.I.F) value is the value of a country's imports of goods, including all charges for transporting and insuring the goods from the country of exports to the given country but excluding the cost of unloading from the ship, aircraft unless it is borne by the carrier.

Free on Board (F.O.B) value is the value of a country's exports of goods, including all costs of transporting the goods to the customs frontier, export duties.

(3) Classification of commodities

Commodities are coded according to the **Harmonised Commodity Description and Coding System Nomenclature (HS 2022)**. However, for the purposes of economic analysis and to facilitate international comparison of trade by commodity data, the commodities are also classified according to the **Standard International Trade Classification (Revision 4) (SITC Rev. 4)**. The HS and the SITC Rev. 4 are six- and five-digit codes respectively but have been extended to eight and seven digits to accommodate national requirements.
