With a GDP growth of 7% in 2023 and a GDP per capital of around USD11.400, Mauritius will soon reach the High-income country status.

Over the last decade, the EU has been providing continuous support to Mauritius in terms of budget support and technical assistance to wide ranging sectors, including climate smart agriculture, healthcare and ease of doing business, among others.

In addition, under the regional Interim Economic Partnership Agreement envelope, a sum of Euro 10 million has been provided for the period 2018 to 2024 to bolster investment and business climate.

The new Country Partnership Framework 2023-2027 sets the tone for stronger engagement with the World Bank Group in sectors of importance to the country.

More recently, the World Bank has chosen Mauritius as one of the first twenty countries to roll out the new Joint Country Representative.

This One World Bank Group – one stop shop approach unifies the role of the Country Representative to represent IBRD, IFC and MIGA at the country level.

This morning actually marked the launch of the new World bank Group office hosted byy the Bank of Mauritius under this set-up.

We trust that this new configuration which is effective as from 1st July 2024, will help engage better and more efficiently with the World Bank Group through integrated solutions spanning both public and private sectors.

This afternoon's event is a historic moment for our the Rodrigues Airport Project.

This strategic project for the island of Rodrigues aspires to enhance air connectivity and contribute to the overall sustainable development of Rodrigues.

As we all know, air transport is an indispensable means of travel for Rodrigues, serving as the link that binds it to the global community.

The construction of the 2,100 meter long runway and associated facilities will allow larger aircraft to land, increasing airport capacity and improving resilience.

Against this background, the World Bank and EU fundings will be utilized predominantly for the construction of the runway and related infrastructure.

The other components of the project are not lesser in importance. They will in fact, ensure a sustainable and integrated development of the island that accompany the improvement in air access.

These components relate mainly to technical assistance and small key investments aimed at enhancing Rodrigues' agri-food system as well as water resources.

Additionally, I am pleased to inform you that support will also be provided ensure the sustainable development of the Tourism Sector in Rodrigues.

Ladies and gentlemen,

The primary beneficiaries of this ladmark project are the 44 000 people of Rodrigues, who will enjoy increased economic activities, investment, employment, and training opportunities, leading to enhanced income, poverty alleviation and quality of life.

Businesses in Mauritius and Rodrigues will benefit from increased trade opportunities and reduced costs due to improved accessibility.

Furthermore, job creation during construction and new airport services will provide more opportunities for workers on both islands.

Last but not least, the project will directly benefit passengers and freight air service providers, perishable goods exporters, spare parts importers, and the tourism industry at large.

Airlines will also profit from an exected rise in passenger transport, reduced travel times, and lower operating costs.

The Rodrigues Airport project is a massive one.

It is actually the biggest project in the history of Rodrigues involving multiple stakeholders.

Proper coordination, collaboration and monitoring are key aspects to ensure smooth and successful project implementation.

Government has made provisions to the tune of Rs 1.4 billion to kick-start the construction of the new runway at Plaine Corail for the financial year 2024/25.

The institutional arrangements that have to be put in place, namely the Project Steering Committee, Project Implementation Unit, Project Technical Units have also an important role to play.

As we move forward, it is worth noting that the Project Steering Committee whose role is to provide regular project oversight, monitor progress and coordinate stakeholder actions has already been set up.

Additionnally, we rely greatly on the support and expertise of the World Bank to accompany us throughout the project implementation phase till completion.
