<p>75A The Rodrigues Regional Assembly</p> <p>(1) There shall be a Regional Assembly for Rodrigues to be known as “the Rodrigues Regional Assembly”, in this Chapter referred to as “the Regional Assembly”.</p> <p>(2) The Regional Assembly shall consist of a Chairperson, who need not be an elected member of the Regional Assembly, and such other members elected and holding office on such terms and conditions as may be prescribed.</p> <p>[Added 32/01]</p>	<p>75A Lasanble Rezional Rodrig</p> <p>(1) Pou ena enn Lasanble Rezional pou Rodrig, ki pou apel “Lasanble Rezional Rodrig”; dan sa Sapit-la, nou pou apel li “Lasanble Rezional”.</p> <p>(2) Lasanble Rezional pou konpoze par enn Prezidan, ki pa oblize enn manb eli Lasanble Rezional, ek lezot manb ki pou exers zot fonksion dapre bann modalite ek kondision ki finn preskrir.</p> <p>[Adision 32/01]</p>
<p>75B Powers of the Regional Assembly</p> <p>(1) Subject to this Constitution, the Regional Assembly –</p> <ul style="list-style-type: none"> (a) shall have such powers and functions as may be prescribed and, in particular, the power to propose and adopt Bills in relation to the matters for which it shall be responsible, which Bills, when adopted by Parliament in such manner as may be prescribed, shall be known as Regional Assembly Laws and shall be so designated in the Short Title; (b) may make regulations which shall be known as Regional Assembly Regulations and shall be so designated in the Heading. <p>(2) Regional Assembly Laws and Regional Assembly Regulations shall apply only to Rodrigues.</p> <p>[Added 32/01]</p>	<p>75B Bann pouvwar Lasanble Rezional</p> <p>(1) Sou rezerv sa Konstitusion-la, Lasanble Rezional: –</p> <ul style="list-style-type: none"> (a) pou ena bann pouvwar ek bann fonksion ki finn preskrir ek, an-partikilie, pouvwar pou propoze ek pou adopte bann Bill ki ena lien avek bann item ki tom sou so responsabilite, ek bann Bill-la, enn fwa ki zot finn adopte par Parlman dan fason ki finn preskrir, pou rekonet sou apelasjon Lalwa Lasanble Rezional ek pou dezigne dan sa fason-la dan zot Tit Abreze; (b) pou gagn drwa fer vot bann regleman ki pou rekonet sou apelasjon Regleman Lasanble Rezional e zot pou dezigne dan sa fason-la dan zot Heading. <p>(2) Bann Lalwa ek Regleman Lasanble Rezional pou aplikab zis dan Rodrig.</p> <p>[Azoute 32/01]</p>

<p>75C Executive Council</p> <p>(1) There shall be an Executive Council of the Regional Assembly comprising of the Chief Commissioner and Deputy Chief Commissioner and such number of Commissioners as may be prescribed.</p> <p>(2) The Chief Commissioner and the Deputy Chief and the Commissioners shall be elected or appointed in such manner as may be prescribed.</p> <p>(3) The Chief Commissioner and the other Commissioners shall have such powers and exercise such functions as may be prescribed.</p> <p>[Added 32/01]</p>	<p>75C Konsey Exekitif</p> <p>(1) Pou ena enn Konsey Exekitif Lasanble Rezional ki pou konpoze par enn Prezidan ek enn Vis-Prezidan ek nonb Komiser ki finn preskrir.</p> <p>(2) Sef-Komiser, Sef-Komiser Adzwin ek bann Komiser pou swa eli, swa nome dan fason ki finn preskrir.</p> <p>(3) Sef-Komiser el lezot Komiser pou ena bann pouvwar ek pou exers bann fonksion tel ki zot finn preskrir.</p> <p>[Azoute 32/01]</p>
<p>75D Rodrigues Capital and Consolidated Funds</p> <p>There is established –</p> <ul style="list-style-type: none"> (a) a Fund to be known as “the Rodrigues Capital Fund” which shall consist of such funds as may be specified for the purposes of development; (b) a Fund to be known as the “Rodrigues Consolidated Fund” which shall consist of – <ul style="list-style-type: none"> (i) such monies as may every year be appropriated by the National Assembly for the recurrent expenditure of the Regional Assembly; (ii) such other recurrent revenue as the Regional Assembly may lawfully collect. <p>[Added 32/01]</p>	<p>75D Fon Kapital ek Fon Konsolide Rodrig</p> <p>Pou ena: –</p> <ul style="list-style-type: none"> (a) enn Fon ki pou apel “Fon Kapital pou Rodrig” e ki pou konpoze par bann fon ki finn preskrir pou ki zot favoriz devlopman; (b) enn Fon ki pou apel “Fon Konsolide pou Rodrig” ki pou konpoze par: <ul style="list-style-type: none"> (i) bann som ki Lasanble Nasional kapav vote sak lane pou bann depans kouran Lasanble Rezional; (ii) ninport ki reveni kouran ki Lasanble rezisional gagn drwa resevwar legalman. <p>[Azoute 32/01]</p>

75E Alteration of certain written laws

Subject to the provisions of the Constitution, any law giving effect to this Chapter and to any matters incidental thereto shall not be altered without the concurrence of the Regional Assembly unless such alteration is supported at the final voting in the National Assembly by the votes of not less than two thirds of all the members.
